I also want to mention that the 2012 Rural Florida EMS Agency Survey report is completed and available for download on our website, www.farems.org. Key findings from this year's survey include:

- Very low staff turnover rate (2.9% overall)
- Use of outside billing service is up nearly 100% (69% of respondents);
- 84% of respondents indicate their community needs primary care resources/access.

Membership Renewal Time

It is that time of year again--2013 FAREMS Membership Forms will be mailed this week and there may be a surprise for you! The Board has re-worked the membership dues structure based on the number of permitted vehicles reported by the agency to the State. The new membership dues for 2013 are as follows:

Agencies with between 0 and 5 permitted vehicles, dues are \$450 Agencies with between 6 and 10 permitted vehicles, dues are \$550 Agencies with between 11 and 15 permitted vehicles, dues are \$650 Agencies with over 15 permitted vehicles, dues are \$750.

For the past few years, FAREMS Agency Member dues have been \$750, regardless of the size of the agency. In an effort to encourage new memberships, and to provide some relief for smaller agencies, the Board decided to re-scale the dues according to the size of the agency as it relates to the number of permitted vehicles (air, BLS, and ALS). So take advantage of the new rates and get those membership forms returned as early as possible!

Vial of Life Program

The Vial of Life program is a smart way to have patient medical information on hand in case of an emergency. People can order the Vial of Life kit (which includes a form and storage bag) fill out important medical, insurance, DNR and contact information, and store in easily accessible places in their home or car—on refrigerator, on front door, in glove compartment. This gives emergency personnel vital information needed to accurately diagnose and treat patients. As an EMS agency, you can partner with the Vial of Life program and get kits for free.
