Bureau of EMS Report (out of agenda order)	Chief Patterson introduced Roy Pippin from the Bureau of EMS. Mr. Pippin reported the following: <ul style="list-style-type: none"> • Florida did not receive AED grants this cycle but will apply again for next year. • The State received nearly \$13 million in funding requests through matching grant program but was only able to distribute \$1.6 million in grants. Funded organizations should receive notice in the next few weeks. • The new 911 dispatch law goes into effect July 1st. Rebecca Cash will be managing data. • Wakulla, Bay and Franklin counties are meeting daily regarding Deep Water Horizon situation. Medics from these counties are on scene 24/7 and non-coastal counties may be asked to assist. 	Information

Ms. Long spoke briefly about EMSSystems' patient tracking and data system that has DOH funding for about another year to assist agencies with start-up. Presentation	Chief Patterson introduced Gary Wingrove from the North Central EMS Cooperative. Mr. Wingrove reported that NCEMSC now has over 2,000 members and is working on national community paramedic curriculum. They have research projects and are looking for participants. NCEMSC offers a leadership conference and is expecting to conduct another in November in New England area.	Information
Staff Report	<p>Tracy Burger gave this report:</p> <p>A. Programs/Grants Ms. Burger noted that the contract with the Florida Office of Rural Health is progressing with the availability of continuing education training for rural agencies through August 2010. Additional funding has been secured through August 2011. Funds were requested to help with matching funds for EMS grants. The stroke/STEMI training contract is complete with 5 agencies receiving training. No additional funding will be provided for such training in the near future.</p> <p>B. Membership Ms. Burger noted the current membership list provided in the meeting packet.</p> <p>C. EMSAC Strategic Plan Ms. Burger reminded the group that FAREMS is responsible for Goal 3.11 of EMSAC's 2008-10 Strategic Plan which is "Increase paramedic and EMT staffing percentage at EMS agencies located in rural counties."</p>	Information

New Business	<p>A. Health Careers Day—AHEC Sponsorship Request Suwannee River AHEC is hosting a Health Careers Exploration Day in Alachua County in September.
